# What is SEC and Why It Matters

The U.S. Securities and Exchange Commission (English: United States Securities and Exchange Commission, abbreviation: SEC), often referred to as the Securities and Exchange Commission, was established under the Securities Exchange Act of 1934, directly under the U.S. federal government, an independent agency, quasi-judicial body, responsible for the U.S. securities supervision and management, for the U.S. securities industry, the highest competent body.

## SEC Registration Requirements:

### Financial

Must submit audited financial reports from the past 1–2 years or, for newer companies, provide proof of startup capital.

### AUM Threshold

Companies must manage at least \$100 million in assets under management (AUM) to register with the SEC. (Firms below this threshold register at the state level.)

### Legal Entity

Must be a legally registered U.S. entity, such as an LLC or Corporation. Overseas firms can establish a U.S. subsidiary.

### Background

Company principals must pass a background check and have no record of financial crimes or securities violations.

*Every country has its own financial regulatory body, such as ESMA in the EU, FCA in the UK, SEC in Ghana, and SFC in Colombia.*

*The U.S. SEC is a federally authorized regulator with independent enforcement power and is highly recognized across global capital markets.*



# How to Verify an SEC Registered Company

Follow these simple steps to verify the SEC registration of a company:

Visit the SEC's official investment adviser query

1. Click "**FIRM**" at the top

2. Enter the company name: **GO INVEST LLC**

3. Click **Search**

4. The system will display the firm's registration details, including regulatory status and licensing.

# Insurance Mechanism

## 1. What is an insurance mechanism?

FlickerAlgo provides optional insurance services for every transaction. When placing an order, users can choose whether to purchase insurance and pay a small amount of premium (0.2%-0.5%), and they can obtain full compensation from the platform when the order is lost, ensuring that the principal is not affected by market fluctuations.

## 2. Why is insurance important?

Even AI smart strategies cannot fully predict all market volatility. The introduction of the insurance mechanism ensures that users can also reduce the risk of loss when encountering extreme market conditions, allowing each investment to have a "safety cushion" and enhance the stability of long-term compound interest.

## 3. Applicable to all servers

From S1 to S6, all servers can enable insurance. Regardless of the transaction time of 4 hours or 72 hours, users can choose whether to enable insurance according to their personal preferences, and flexibly respond to different funding plans and risk preferences.

## 4. Real case description

For example, if you invest \$1,000 and enable insurance, the premium is 0.5%, which means \$5 is deducted. If the transaction loses \$120, the system will automatically compensate the \$120 without manual application. The compensation funds will be returned to your account balance immediately and continue to participate in the next transaction.
